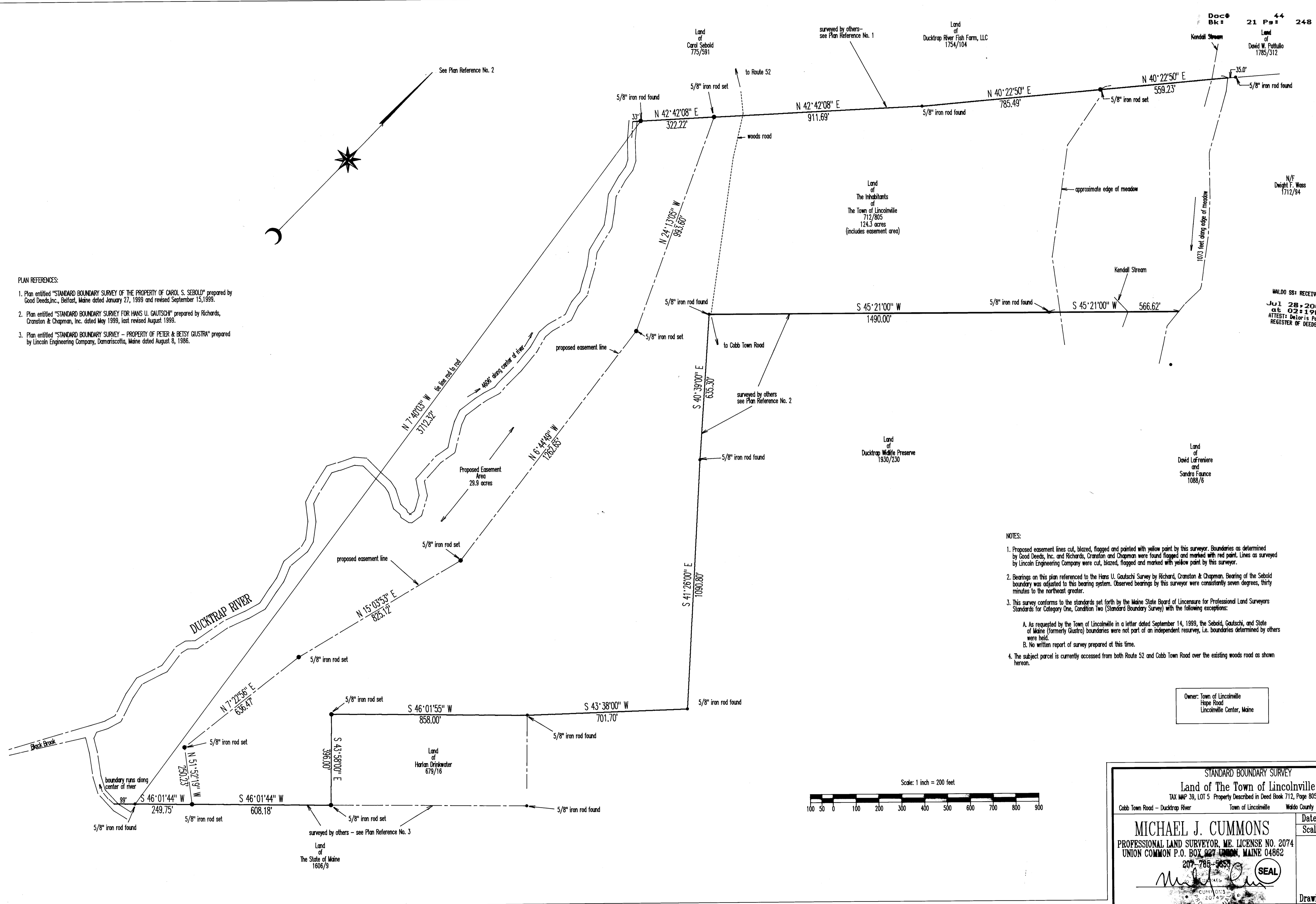


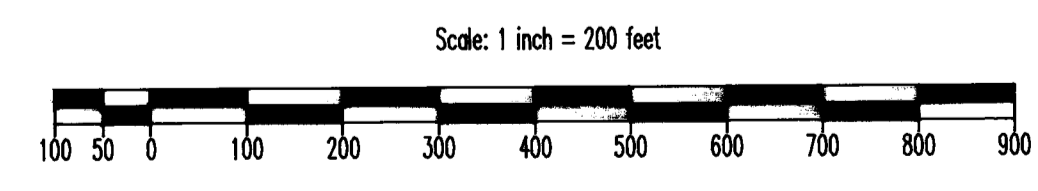

- NOTES:
1. Proposed easement lines cut, blazed, flagged and painted with yellow paint by this surveyor. Boundaries as determined by Good Deeds, Inc. and Richards, Cranston and Chapman were found flagged and marked with red paint. Lines as surveyed by Lincoln Engineering Company were cut, blazed, flagged and marked with yellow paint by this surveyor.
  2. Bearings on this plan referenced to the Hans U. Gautschi Survey by Richard, Cranston & Chapman. Bearing of the Sebald boundary was adjusted to this bearing system. Observed bearings by this surveyor were constantly seven degrees, thirty minutes to the northeast greater.
  3. This survey conforms to the standards set forth by the Maine State Board of Licensure for Professional Land Surveyors Standards for Category One, Condition Two (Standard Boundary Survey) with the following exceptions:  
 A. As requested by the Town of Lincolnville in a letter dated September 14, 1999, the Sebald, Gautschi, and State of Maine (formerly Giustra) boundaries were not part of an independent resurvey, i.e. boundaries determined by others were held.  
 B. No written report of survey prepared at this time.
  4. The subject parcel is currently accessed from both Route 52 and Cobb Town Road over the existing woods road as shown hereon.
