I'm responding back to the denial. As mentioned in a letter I sent with my paperwork, I wanted to talk to someone because there was more and I did not have all the paperwork with all the dates things were filed. I'm doing this on my own and I do not have a lawyer which I did put in and never heard back. I do not know if I sent it to the right place. I would like to have a court appointed lawyer to help me with this, but I need the right direction on where to go to find one. *I received the paper work on 3/6/26.*

Yes, I just looked back and there was no date on the paper I sent in. But I did get it out in December before the holidays before the deadline. And the reason why not a lot was filled out is because I do not have every single document in my room with all the dates when everything was filed.

So, there were a few things mentioned in the denial from the AG. One of them was the statements I made to Shawna Gatto. When I was arrested and brought down to Two Bridges Regional Jail, I was 6 months pregnant. I was put into a bubble where I was not able to talk to anyone. Not too long after I was in the bubble, Shawna Gatto talks to the detectives on my case, and I did receive the transcript when I was in the bubble. So, tell me this. How in the world was I able to talk to Shawna Gatto while I was in the bubble? I believe she did what she did to lower her sentence or something.

This might not have been in the denial part but why did the reports from DHHS not get mentioned during my trial? Instead, it was not released until after I got sentenced. I believe the state was holding back on that and if DHHS was called to where I lived where everything was happening, why was nothing done about it? DHHS, hospitals, or any other medical places we did go to did nothing about anything that happened. They all completely failed to do their job.

Another thing that was mentioned was the pictures that the Attorney General said were not bad that was taken about a week after I got arrested and the

marks on me is what Julio Carrillo did to me. Did you know when I got abused, Julio Carrillo always put bruises on me and all where no one cannot see them when covered with clothes? I understand the condition that my daughter was in was way worse, but these pictures should have been presented during my trial.

I want to point something else out as well. What physical evidence does the state have on me? When my trial lawyer questioned one of the detectives on my case during my trial, my trial lawyer pulled the cart in front of him and asked "Does anything in this cart or any evidence in here point to my client?" His answer was "No." Then my trial lawyer asked if the only evidence they had on me was the police interviews and the detective said "Yes." During my second interview with the detectives, I felt like they forced me to say things and I was scared of Julio Carrillo if I did not take any responsibility. I was in a really bad abusive relationship, and I feel like the Jurors, the judge and the AG did not care at all. Yes, the trial was based on what happened to my daughter, but do they understand the reason why I confessed what I did? Apparently, they did not understand because they did not see and understand the nature of the kind of relationship I was in.

As I was reading through all the paperwork I did receive, it said something about me not taking my daughter to the hospital. That was completely false. I begged Julio Carrillo to take us to the hospital. Julio Carrillo did not comply with that because he was afraid that the police would get involved. Also the day my daughter passed, as I was performing CPR while she was still alive, I begged Julio Carrillo who had a smile on his face to call 911 numerous times and he finally did after 25 minutes.

As I mentioned above, I would really like to talk to someone and hopefully a court appointed lawyer to help me with all of this. Thank you for your time on reading this.
